



**Game On! Sports Camps & Programs 4 Girls**  
**PERMISSION SLIP, RELEASE, INDEMNIFICATION & HOLD HARMLESS AGREEMENT**

You have registered to participate in one of our active fitness and/or sports camps and programs. By so doing, you understand that your participants will be running, jumping, and engaging in all sorts of activities and movements, sometimes with added sports equipment and/or reasonable field/court/gym equipment and sometimes without. There are always physical risks involved, some major. By participating you absolve ALL parties, individuals, organizations, etc. involved in this program of all liability and also agree to the following:

In consideration of participating in sports activities, programs, events, clinics, and camps, and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence Game On! LLC a/k/a Game On! Sports Camps 4 Girls, or Game On! Programs 4 Girls or simply Game On!, and its owners, directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:

I acknowledge that participating in sports activities involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death, and property damage. Risks include, but are not limited to, broken bones, torn ligaments or other injuries as a result of falls or contact with other participants; death as a result of drowning or brain damage caused by near drowning in pools or other bodies of water; medical conditions resulting from physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment and taking all reasonable precautions, without jeopardizing the essential qualities of the program.

On behalf of myself, my children, or anyone I am authorized to sign for (collectively referred to as "my or myself or I"), I expressly accept and assume all of the risks inherent in all activities or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or mental conditions, then I have the ability to and will immediately discontinue participation.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume - and bear the costs of - all risks that may be created, directly or indirectly, by any such condition.

In the event that I file a lawsuit, I agree to do so solely in the state where Releasees' facility or site is located, and I further agree that the substantive law of that state shall apply. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

Game On! LLC, A/K/A Game On! Sports Camp 4 Girls and Game On! Sports 4 Girls, their licensees, and other associated partners have permission to use photos or video of my camper/participant for any promotional use, including website, brochures, video, Game On! Publications, social media, or the like. Note that your camper's/participant's full name will not be identified in promotional materials without additional parental consent. I also give permission for me or my authorized participant(s) to take part in studies conducted as a part of legitimate research Game On! or the Game On! Scholarship Fund is conducting at any given time taking confidentiality into full consideration but with permission to use full names and other identifying information.

I understand that Releasees strongly recommend that all participants use any and all protective gear, including protection for eyes, nose, mouth and the face in general as well as headgear. Releasees will not provide any protective gear given the risks associated with sanitary conditions and factors.

Allergies: Game On! maintains a strict policy with regard to preserving a peanut free and nut free campus/program site and forbids the sharing of food for all camps and programs. If food is part of the Game On! experience (snacks, lunch, etc.) or traces of food were left behind and your participant suffers from allergies, you understand there are major health risks involving food allergies and your participant. Despite strict policies, you understand the risks, and release, waive and forever discharge from any claims, liability, and damages all released parties related in any way to the participant and allergic reactions.

You give all released parties herein, including all those running the program on-site, permission to take emergency measures including calling 911 should an accident occur, and you agree to assume all responsibility and expense incurred.

By acknowledging this document, I agree that if I my child or other authorized participant is hurt or property damaged during participation in this activity or series of activities, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence. I have had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain. In consideration of this individual or individuals being permitted to participate in this program, I further agree to indemnify and hold harmless releases from any claims alleging negligence which are brought by or on behalf of minor or are in any way connected with such participation by minor.

## **COVID-SPECIFIC PERMISSION SLIP, INCLUDING CERTAIN WAIVERS, FOR GAME ON! SPORTS CAMPS 4 GIRLS**

You are registering for Game On! Sports Camp 4 Girls, thus bringing various COVID-specific permissions and waivers into play.

- 1) You understand that Game On! cannot control every possible risk. While we wish that we could control every possible risk, and while we will use our best efforts to keep everyone as safe as possible from the COVID-19 virus and other potential associated outbreaks, we want to make clear that we cannot promise or guarantee that this or any other pathogen will not enter our campsite or other designated program location, and that by the very nature of in-person interaction of any kind that takes place at our campsite or associated program location, there is always a risk of your participant or someone else becoming ill with this or any other communicable disease. With this in mind, you agree not to bring any kind of legal proceeding, lawsuit, or seek damages or reimbursement for medical expenses through any other method unless there is intentional and purposeful wrongful behavior on the part of Game On! Sports 4 Girls.
- 2) We believe that our ability to run any and all programming in a manner that meets with our safety standards during time periods where Covid-19 (or any other pandemic or disease outbreak) is contingent upon our ability to comply with CDC and other state and local guidelines, which may include the performance of COVID 19/pandemic tests on every participant and staff member. This may also likely include social distancing and wearing protective gear such as masks.
- 3) You understand that all sports and fitness equipment used during programming, whether the property of Game On! or that of a third party, will have to meet specific sanitization standards and undergo procedures in line with CDC and other local and state guidelines. This means sanitizing/disinfecting with an “approved” solution both before and after use if the equipment is to be shared.
- 4) YOU AGREE THAT if at any time your participant(s) feels ill, or a member of your household or family feels ill, it is incumbent upon you to immediately notify the Game On! office and cancel all scheduled camp/program days until the requisite quarantine period is over or for the remainder of the season in order to guarantee the safety and health of all involved. (Credit or full, partial or prorated refunds will apply as determined on a case by case basis.) Similarly, any Game On! staff member who feels ill will immediately notify the Game On! office and cancel all scheduled program sessions pending the requisite quarantine period or the remainder of the session, if in the best interest of the safety and welfare of all involved. If a program participant begins to feel ill during a session, she or he will immediately safely distance under the supervision of the Game On! staff member, and parents, guardians or responsible adults will be expected to take responsibility for their participant as soon as possible, making sure to remove her or him from the camp or program premises. If a Game On! staff member begins to feel ill during the course of a program session, she or he will immediately distance, contact the Game On! office and when responsibly possible, leave the premises.
- 5) YOU AGREE that you will inform the Game On! Office within a period of two weeks from the start of or within two weeks after the completion of our programming, if your family or household residents have experienced any symptoms of the COVID 19 virus or have been in close contact with anyone who has experienced such symptoms or been diagnosed with COVID 19. It is within everyone's right to cancel your

future programming sessions to the extent necessary and in the best interest of all involved. Full or partial refunds are not guaranteed and are within the discretion of Game On!. Credits may apply.

6) You agree to let us know if your participant has any condition that the CDC, state or local guidelines define as being a member of a high risk or vulnerable population. This includes chronic lung disease, moderate/severe asthma, serious heart conditions, immunocompromised conditions such as ulcerative colitis or Crohn's disease, severe obesity (body mass index [BMI] of 40 or higher), diabetes, chronic liver and/or kidney disease (undergoing dialysis). This information is necessary for us to provide a safe environment for you and the rest of camp or program staff and participants, and to enable us to make reasonable accommodations or decisions that may be required.

7) All emergency medical circumstances will be handled by a call to 911. If your campsite has a certified trainer on-site, the trainer will determine what to treat, what to leave to 911, and what to leave the responsibility of parents or responsible adults listed on participants' emergency forms.

8) All payments will be made in full and relevant waivers signed prior to participation in Game On! Programming. Game On! has the right to refuse the participation of anyone not paid in full or without executed waivers/permissions/indemnifications.

9) All parents, responsible adults, and guardians have also read through Game On!'s COVID safety practices and procedures and understand fully and agree. You can find this document on [gameonsports4girls.com](http://gameonsports4girls.com).

10) We want to make clear that these additional requirements are solely for the purpose of trying to keep our programming community as safe as possible, and that any failure to comply may endanger the health and safety of the participants entrusted to our care as well as colleagues and families.
