Dear Doctor,

Your Patient has applied to participate as a member of the *Canadian Contingent to the 25th World Scout Jamboree in South Korea*.. This event will be taking place between the 27th of July and 13th of August, 2023. This Jamboree will be very physically demanding. Participants will be expected to walk long distances (up to 10km or more per day), and will also be required to sleep in tents, in an area with over 40,000 other participants. There will be no electricity available in the area where these participants will be camping. The climate in this location is hot with average highs of 26C and lows of 15C; however, there is the possibility of heat waves and high humidity at this time of year. Many of the youth activities can be very challenging (ie. climbing walls, obstacle courses, etc.).

Previous experience at similar events has taught us that the aforementioned conditions are not always well suited for the physical and psychological capacity of some individuals. We would appreciate your opinion on your Patient's capabilities at this event, particularly what accommodations might help this individual participant in their jamboree experience..
